# Customs declarations on diplomatic goods

Diplomatic goods are exempt from customs duty on certain conditions. Goods exempt from customs duty must also be declared to Customs.

## Conditions for exemption from customs duty

Goods are exempt from customs duty when they are brought into Finland

- for the official use of diplomatic missions operating in Finland or
- for the official use of other foreign missions and consulates that hold an equivalent status.

Goods are also duty-free if they are imported for the personal use of diplomats, consuls or technical personnel and their family members.

The goods cannot be granted exemption without a so-called French paper certified and stamped by the Ministry for Foreign Affairs of Finland. However, the French paper is not required for diplomatic mail containing documents.

# How to declare your goods

You identify yourself in the Customs Clearance Service using your Finnish online banking ID codes, your mobile certificate or your certificate card. Please note that private individuals cannot use the Finnish Authenticator app to identify themselves.

Log into the Customs Clearance Service.

- If you are submitting the declaration yourself, select "I represent myself".
- If you are lodging the declaration on behalf of a company, select "I act on behalf of some company". You need an authorisation to act on behalf of a company. More information on authorisations: This is how you grant a mandate in practice.

Click on + New declaration.

Select the declaration "Import, I am receiving goods".

In the box, select the country of dispatch from where the consignment is arriving and confirm the selection by clicking on the box. If the consignment is arriving in Finland from the Canary Islands (tax border declaration), select Spain as the country of dispatch. A customs declaration must be submitted for consignments sent between Åland and mainland Finland. Guidance for this can be found on the page <u>Åland tax border trade</u> (in Finnish and Swedish).

As the customs procedure code, select 40, Release for free circulation from other customs procedure.


If you have an arrival ID or item tracking ID, enter it in the field. It is not a mandatory detail.

Customs declaration >>

When you click on the question mark with the left button of the mouse, you are shown information on the details to be provided in the field.



The details marked with a red asterisk are mandatory. This instruction covers the details you need when filling in the customs declaration.



If you have not filled in all the required details, the system will display the missing detail in red when you click on the Next button.

The declaration consists of three parts: Parties, Declaration header and Goods items. Fill in all parts and when complete, submit the declaration to Customs.



More specific user instructions can be found in the top right corner under Help and documentation.



If you have added details by mistake by clicking on, for example, + **Add authorisation**, you must remove the additional fields before submitting the declaration. You can remove the field by ticking the box next to the detail you wish to remove and then clicking on the button **Remove selected**.

# I. Parties



Name and email address of the person providing additional information.



If you are declaring goods for the use of a diplomatic mission, you cannot tick the box "Use the details of the authenticated trader". In that case, enter the name, address, postal code and city of the person responsible for the data content of the declaration. Enter the business identifier in the field Identification number. For private individuals, enter the personal identity code or for foreign nationals, the country code and date of birth (ddmmyy), e.g. US210360.



If you are declaring goods for the use of a diplomatic mission, you cannot tick the box "Use the details of the authenticated trader". In the Importer details, enter the name, address, postal code, city and country code of the consignee. Enter the business identifier in the field Identification number. For private individuals, enter the personal identity code or for foreign nationals, the country code and date of birth (ddmmyy), e.g. US210360.

Exporter

Enter the details of the sender under Exporter. In the Exporter details, you enter the sender's name, address, portal code, city and country.

When you have provided all the details, click on **Next**.

### 2. Declaration header

**Trader reference** is a mandatory detail that you give to the customs declaration yourself.

Select A as the **Additional declaration type** if the consignment is in Finland. If the consignment has not yet arrived, select D as the additional declaration type You can provide a pre-lodged declaration of type D only if, when lodging the declaration, you have access to the details of the previous document provided by the transport company. In such cases, you must provide the entry summary declaration or T1 transit as the previous document. It is not possible to select an additional declaration type in tax border declarations.

Leave the field **Exceptional tax determination date** empty. It should only be filled in if the consignment has been imported to Finland at an earlier date and the customs declaration is lodged retrospectively.

The amount and value details, such as **Total amount invoiced** and **Invoice currency** should be left blank.

Enter the **Total gross mass (kg)** of the consignment.

Under **Nature of transaction**, enter code 99 – Other (not specified), if the consignment is non-commercial. If the goods were purchased, enter code 11 – Outright purchase/sale under **Nature of transaction**.

The Delivery terms are provided using an INCOTERMS code. You can for example select the terms XXX – Other delivery terms. The field **Location (UN/LOCODE)** should be left blank.

Under **Location**, you provide the location, for example Helsinki, and under **Country**, which is a mandatory field, you provide FI – Finland.

Under **Transport information**, you should first provide the mode of transport and the nationality of the means of transport that crosses the border of the EU territory.

Under **Inland transport mode**, you should provide the means of transport on which the consignment has been brought or will be brought to the location. The location can be, for example, the customs office of entry to which the consignment has been carried by sea, air or road.



In the **Route** details, enter the country of dispatch (e.g. China) and the destination country (e.g. Finland). These details are prefilled in a tax border declaration.

In the details on **Locations**, you must provide the Identification of warehouse (format: FI1234567-800101) if the consignment is in, for example, a customs warehouse. If the goods are at the customs office of entry, provide the address details of the customs office.

The **Proposed control location** is  $\mathbf{B}$  – **Authorised place** if, for example, the consignment is in a customs warehouse (Qualifier of location X and warehouse identifier FI1234567-800101). If the consignment is not in a warehouse, select  $\mathbf{D}$  – **Other**. Enter the address of the location: street address, postal code and city.

Do not select Add information if you do not have additional information to submit with the declaration.

Do not remove the additional information code FIPDF, because you need the decision in PDF format

Enter the container ID, if the consignment arrives in a container.

When you have provided all the details, click on Next.

### 3. Goods items



Add the **previous procedure** 00 – No previous procedure.



Select 622 – Diplomatic goods as an **additional procedure**. **Confirm the selection by clicking on the + Add button.** 

3RJ - Miscellaneous documents and articles sent free of charge to authorities and organisations (Article 104 Duty Relief Regulation, section 94(1)(16) VAT Act)

Select 3RJ – Miscellaneous documents and articles sent free of charge to authorities and organisations as an additional procedure, if the consignment only contains documents. Confirm the selection by clicking on the + Add button.

F15 - Goods introduced in the context of trade with special fiscal territories (H5-EU)

In tax border declarations, the **additional procedure** F15 is prefilled. Add the **additional procedures** 622 and 3RJ to the declaration.

**Origin country** is a mandatory detail, so provide the country of dispatch here.

The **commodity code** of diplomatic goods is provided using code 9905000000 – personal property belonging to natural persons transferring their normal place of residence. The commodity code of diplomatic mail can be provided using, for example, code 4911990000. Do not include spaces in the commodity code.




As the **goods description**, describe the content of the consignment, e.g. Diplomatic goods. If the consignment only contains documents, describe the content as e.g. Diplomatic mail.

Commodity code 4911990000 is subject to restrictions. If the consignment does not contain any goods subject to restrictions, select Y069 and/or Y949 as the negation code.




Under **Kind of packages**, you should provide the package type (e.g. BX – Box or BG – Bag), the number of packages and shipping marks. If the packages are unmarked, enter the text "No markings".


A **previous document** must always be provided. Ask the freight carrier to provide the type of the previous document and the MRN, as well as the sequence number of the goods item. The goods item sequence number is not needed in the case of transit declarations. If you are transporting the consignment yourself, provide ZZZ as the document type and the date of arrival as the reference.



If the consignment contains a vehicle, enter the vehicle identification number under **Additional information** using additional information code FIXBC.



Enter the "French paper" under **Additional documents** using additional document code 1ZZZ or 3EHS. You can add additional documents by clicking on + Add document.



Enter the **net mass** of the consignment.

Enter the **statistical value** of the consignment. The statistical value cannot be 0.

The **transaction price** is a mandatory detail. Enter the transaction price using the value 0 - EUR Euro.



As the **valuation method**, select 6 – Value based on the data available.

As the **preference code**, select 100 – Tariff arrangement erga omnes.

You can add additional goods items by clicking on + Add goods item.

If the declaration is complete, you can click on Next.

#### Validation errors



#### Parties > Exporter

C0618 - This detail is mandatory, except in customs warehousing, where it must not be provided.

If you have not provided all the required details, the system will display a validation error on the page Summary and submission, and this will help you find the detail that is missing. In this example, the missing detail is found in the tab Parties under the heading Exporter. The details on the Exporter are missing from the declaration.

When the declaration is complete, send the declaration by clicking on the **Submit** button. After the declaration has been successfully submitted, the declaration has the status Accepted and is given an MRN as a reference number. Completed decisions can be found on the page Summary and Submission under Documents.
