


WEB AREX: User's Instructions and Completion Rules




FRONT PAGE

On the front page of the web service, you will find general information on the application, a link to the terms of use and to the user's guide, system info and information on the call centre.

On the front page of the web service, all users can select the language of the user interface (the default language is Finnish; the other alternatives are Swedish and English). Customs' messages to customers will be completed in the language of the selected user interface.


Users can log in to Web AREX by clicking the '**Log in using KATSO ID**' link.



FRONT PAGE (IDENTIFIED USER LOGGED IN USING KATSO ID)

A user who has logged in using the KATSO ID sees a page showing the companies linked to the KATSO ID in question. The declarant must always select from the menu the company in whose name he or she will submit declarations. Change of company requires logout and new identification using the Business ID of the other company.

If there is only one Business ID registered under the KATSO ID, the user should press the '**Continue**' button.



At the top of the page, a holder of the KATSO ID can see the ID used to log in to the web application.

Identified users can see

1. the Search tab, where they can search the declarations they have submitted, using certain search criteria.
2. the Declaration tab, where they can choose among the types of declarations available to them.

GENERAL INSTRUCTIONS

The tooltips associated with the fields to be completed will guide the completion of a declaration box-by-box. Tooltips mean contextual help elements that pop up in the hint box that appears when the user moves the mouse cursor over the field to be filled in and clicks the left mouse button.

Any field marked with an asterisk * is mandatory. A field marked with an asterisk in brackets (*) indicates that a condition exists to enter this information.

Formatted texts cannot be inserted into the declaration fields. If formatted text is copied e. g. from a Word document and pasted into a declaration field, the formatting of the pasted text will not be preserved (but the text will remain in the field). However, HTML tags used for formatting, such as , cause an error message even before the declaration can be sent.

Next to the date fields there is a calendar where you can select the desired date. In some date fields, the time shall also be entered. In addition to the selected date, the default time 00:00, which the user must change, is shown in the field. The date can also be entered directly in the date field, in the form dd.mm.yyyy (e.g. 24.08.2009).

By clicking the menu arrow, the user sees the list of the alternatives from which to select. To select the desired alternative, you click it with the mouse. You can also type text in the field, and then you see the alternative beginning with the letter you typed in the field.


If there is an 'abc' box in the end of a field and when you type at least 2 characters of a code or a code description you'll see a menu where you can select the alternative you want. The application shows all the alternatives with the letter combination you typed. This function is also available for entering the country codes (e.g. if the country of destination is the Russian Federation, you can start by typing ru). The more characters you type the easier it is to find the right alternative.

BUTTONS DISPLAYED IN ALL THE SCREENS

By clicking '**Previous**', the user can return to the previous page.

By clicking '**Cancel**', you can empty the fields if they were empty before the data was entered. If the fields contained data that had been entered earlier and these data were then changed, clicking 'Cancel' will return the original data.

By clicking '**Next**', the user can move to the next page. After clicking this button, the application will display an error message if compulsory data are missing.

	<p>The 'Save' button will also be enabled for identified users allowing them to change information that has already been saved, e.g. when correcting errors. Later in summer 2010, a click on the 'Save' button will also save the data of an unfinished declaration as a draft and the user can continue entering the data later.</p>

615 EXIT SUMMARY DECLARATION, MAIN PAGE (IDENTIFIED USER)

On the declaration main page, the AREX application shows information on processing of an accepted declaration. **No data can be input from this screen.**

The MRN is a unique number issued by the AREX application for every declaration. The MRN is issued by the AREX system upon its acceptance of a correct exit summary declaration.

The declaration registration date is the date when Customs receive and accept the declaration.

The state of the declaration is a data item generated by the AREX system which makes it possible to follow the progressing of the declaration at Customs. Certain states of a declaration or goods item (Error, Control, Rejected by control) require customer's action. A separate instruction has been issued for the correction of a declaration.

Web reference is a reference number issued by the Customs system for a declaration lodged using the web channel. The reference number is generated when a new declaration is saved as a draft through the AREX application for the first time. Saving as a draft will be made available in summer 2010 at the earliest.

BASIC INFORMATION

On the **'Basic information'** page you enter the data concerning the whole exit summary declaration.

The language of communication is the language selected on the AREX front page for the user interface. The default language is Finnish but it can be changed to Swedish or English. You must return to the front page to make this change.

Unique consignment reference number can be declared either for the entire declaration or for each goods item. If the unique consignment reference number is not provided at all, then the 'Produced Documents/Certificates' field must be completed with at least one transport document for each goods item.

Total gross mass must be entered, if the entry for the 'Specific Circumstance Indicator' is not 'E' (authorised economic operator).

Agreed location of goods must be entered, if the 'agreed location of goods' code is not a customs office. If the 'agreed location of goods' code is a customs office, this information is not entered and the customs office code must be entered in the relevant field.

TRADER'S DETAILS

On the **'Trader's details'** page, enter the details of the declarant, representative, consignor and consignee.

The person responsible for lodging a declaration, the declarant, must have an EORI number. A separate guidance has been issued on how to apply for EORI. The carrier has the primary responsibility to lodge an exit summary declaration. The declaration may also be lodged by any person who is able to present the goods in question. The carrier or any other person lodging the declaration may appoint a representative.

If the declaration is completed by a representative, enter the representative's details. The representative must have an EORI number as well.

If an exit summary declaration contains several consignors or consignees (the consignor or the consignee is not the same for all goods items), the data is saved on the 'Goods item' screen for each goods item.

The details of the declarant, representative, consignor and consignee can be displayed and completed by pressing the **'Representative Display'**, **'Consignor Display'** or **'Consignee Display'** bar.

Trader's name and address details are only saved if the trader (consignor, consignee) don't have a valid EORI number. If your EORI number is valid trader's name and address details need not be saved. The name and address details will be retrieved from the customer registers of Customs when the declaration is sent to Customs.

TRANSPORT DETAILS

Data relating to the transport of the goods are entered on the '**Transport details**' page.

In the 'Countries of routing' field you enter the codes for the countries through which the goods will be transported from the original country of dispatch to the final country of destination. Countries of routing should be entered where known, but the final country of destination must always be entered on an exit summary declaration. You add routing countries by clicking "**Add line**", and the routing country you added earlier will move above the field. You can remove entered routing countries by clicking "**Delete**".

If there is only one routing country, you don't need to click the 'Add line' button.

If no seals are related to the declaration, this field is not completed.

If there is more than one (1) seal, you add seal identifiers by clicking "**Add line**". The entered seal identifier will move above the field. You can remove an identifier by clicking "**Delete**".

GOODS ITEM DETAILS

On the **'Goods item'** page, you enter the details of one goods item.

AREX checks directly from the TARIC database that the commodity code is correct.

If an exit summary declaration contains several consignors or consignees (the consignor or the consignee is not the same for all goods items), the data is saved on the 'Goods item' screen for each goods item. The details of the consignor and consignee can be displayed and completed by pressing the **'Consignor Display'** or **'Consignee Display'** bar.

If goods of one goods item have been packed in several different package types, all the package types must be entered.

After entering the data on one package, click the 'Add line' button, and the entered data move above the field and you can enter more package details on the same goods. You can remove entered package data by clicking **"Delete"**.

If the goods in the goods item are packed in the same package type, you don't need to use the 'Add line' button.

Produced documents relating to the goods item are not compulsory data in all cases. If you want to enter several produced documents, click the **'Add line'** button.

You can delete an entered produced document from the summary by clicking **'Delete'**.

The container number should only be entered if the goods are containerized. If the goods have been loaded into several containers, click the **'Add line'** button. The entered data move above the field and you can enter more package details on the same goods. You can remove entered container numbers by clicking **"Delete"**.

If the goods have been packed into one container, you don't need to use the 'Add line' button.

As regards goods items, 'Previous procedure' means the procedure or another declaration under which the goods arrived at the office of exit. If an exit summary declaration is preceded by an electronic entry summary declaration (code 1702) or an electronic summary declaration for temporary storage (code 1702), the relevant goods item numbers on the declarations must also be entered.

If the declaration covers two or more items, you can add a new goods item by clicking the **'Save and add new item'** button.

‘SUMMARY AND SENDING’ PAGE


AREX creates a summary of the entered data.

The person who completes the declaration may, if he so wishes, return to the previous screens to amend the details either by **selecting the required page from the side navigation bar** or by clicking the **‘Previous’** button. To amend the details, the **‘Save’** button of the page in question must be clicked.

The completed exit summary declaration is sent to Customs by clicking the **‘Send declaration’** button on the ‘Summary and sending’ page.

The summary can be printed by clicking the **‘Print declaration’** button.



Before accepting the declaration, AREX checks that you have entered the compulsory data.



If compulsory data are missing, AREX will display an error message and request the user to correct the errors before resending the declaration.

The user can correct the error by using the **side navigation** to move to the page where the error was detected. You can also move from one page to another by clicking the **'Previous'** button. To amend the details, the **'Save'** button of the page in question must be clicked.

After correcting the error, the user can resend the declaration by clicking the **'Send declaration'** button on the 'Summary and sending' page.

BASIC INFORMATION

On the **Basic information** page you enter the data concerning the whole exit manifest presentation. A manifest presentation can cover several MRNs and goods items possibly related to it.

The language of communication is the language selected on the AREX front page for the user interface. The default language is Finnish but it can be changed to Swedish or English. You must return to the front page to make this change.

Enter either the conveyance reference number or the identity of means of transport.

The total number of packages must represent the total number of packages of all the presentation items (e.g. the packages of the export and transit items to be presented). The total number of packages is equal to the sum of all "Number of packages", all "Number of pieces" and a value of "1" for each declared "bulk".

TRADER'S DETAILS

On the **'Trader's details'** page, enter the details of the declarant, carrier and, if needed, the details of the representative.

The person responsible for lodging a declaration, the carrier, must have an EORI number. A separate guidance has been issued on how to apply for EORI.

If the declaration is completed by a representative, the representative's details must also be entered. The representative must have an EORI number as well.

The details of the representative can be displayed and completed by pressing the **'Representative Display'** bar.

If your EORI number is valid trader's name and address details need not be saved. The name and address details will be retrieved from the customer registers of Customs when the declaration is sent to Customs.

PRESENTATION ITEM

On the '**Presentation item**' page, you enter the details one item to be presented.

Enter in the 'MRN' field the MRN assigned by the Finnish export control system, summary declaration system or transit system to the goods to be presented for exit. A MRN issued by an export control system of another EU country or another export reference can be used as of summer 2010.

The total gross mass may only be used if the MRN to be presented is a MRN issued by the Finnish export control system, otherwise the total gross mass can not be entered. Entering this data is optional.

The number of packages may only be used if the MRN to be presented is a MRN issued by the Finnish export control system, otherwise the number of packages can not be entered. Entering this data is optional.

The number of pieces may only be used if the MRN to be presented is a MRN issued by the Finnish export control system, otherwise the number of pieces can not be used. Entering this data is optional.

The '**Leaving entirely**' entry is to be used only when the MRN to be presented is a MRN issued by the export control system and the item declared in the export declaration leaves entirely. If only part of the item declared in the export declaration is leaving, this field must not be used. When the last part of the item declared in the export declaration is leaving, the 'Leaving entirely' entry should be used for the item to be presented.

The goods item number should only be entered in the 'Goods item' field when the MRN entered in the 'MRN' field and presented for exit was issued by AREX.

If the declaration covers two or more presentation items, you can add a new item by clicking the '**Save and add new item**' button.

‘SUMMARY AND SENDING’ PAGE

AREX creates a summary of the entered data.

The person who completes the declaration may, if he so wishes, return to the previous screens to amend the details either **by selecting the required page from the side navigation bar** or by clicking the **‘Previous’** button. To amend the details, the **‘Save’** button of the page in question must be clicked.

The completed exit manifest presentation is sent to Customs by clicking the **‘Send declaration’** button on the ‘Summary and sending’ page.

The summary can be printed by clicking the **‘Print declaration’** button.

The state of the declaration is a data item generated by the AREX system which makes it possible to follow the progressing of the declaration at Customs. Certain states of a declaration or goods item (Error, Control, Rejected by control) require customer's action. A separate instruction has been issued for the correction of a declaration.

Web reference is a reference number issued by the Customs system for a declaration lodged using the web channel. The reference number is generated when a new declaration is saved as a draft through the AREX application for the first time. Saving as a draft will be made available in July 2010 at the earliest.
