### Attachments

Attach to the declaration

- a possible notice of arrival provided by the transport company
- a general list of the removal goods (e.g. "one bed, 20 kg of clothes, 5 kg of books, tableware").

Also attach additional documents, if any:

- certificate of employment or some other proof of your residence abroad
- copy of passport
- copy of both sides of residence permit granted for at least a year (other than a residence permit for studies or granted based on a family members studies) for persons who need a residence permit
- copy of registration certificate of a car
- other proof or authorisation if you have applied for an exceptional permit for removal goods or an import licence for any weapons if you have them among your removal goods

Attachments are needed to process the declaration.

If you bring the goods in yourself, present them along with the completed form to a customs official at the nearest open customs office. Otherwise, send the declaration and its attachments primarily by secure email to [lomaketullaus@tulli.fi](mailto:lomaketullaus@tulli.fi). [Check the instructions on how to send secure email.](#)
