## 5. Additional information

You can provide more information on the consignment. If you're declaring the goods on someone else's behalf, enter here the person's name, address in Finland, citizenship and personal identity code. If you're declaring alcohol, enter the amount in litres and the percentage of alcohol by volume. If you're declaring a vehicle, enter the vehicle's identification number (VIN) and attach a copy of the vehicle's registration certificate.

## Attachments

Attach at least the following to the declaration:

1. the arrival notice and
2. an order confirmation, receipt or some other document showing the value of the goods or information on the gift and its value

Attachments 1 and 2 are needed to process the declaration.

3. If you're declaring removal goods, remember to attach the declaration on goods imported as removal goods, 45e. If you're arriving in Finland as a student and declaring goods for your studies, remember to attach a copy of the residence permit for studies or a certificate of student status certified by the educational establishment. The copy of the residence permit must contain both sides.

Attach additional documents, if any:

Declaration on goods imported as removal goods, form 45e

Copy of the residence permit for studies or certificate of student status certified by the educational establishment

Repair invoice or proof of repair or replacement under warranty

Proof of the goods being exported for repairs or replacement

Document concerning preferential tariff treatment

Other proof or authorisation
